

UNDER ARMOUR DFC COMPETITION - TERMS AND CONDITIONS

This document sets forth the Terms and Conditions under which Under Armour will carry out a competition to win an Under Armour training kit when you purchase a ticket to the Under Armour Dubai Fitness Challenge.

Throughout this document, Under Armour will be referred to as the 'Promoter' and the Under Armour Dubai Fitness Challenge Competition will be referred to as the 'Competition'

Only residents of the United Arab Emirates are eligible to take part in this. Employees of Under Armour and their family members are not eligible to enter.

1. Competition Period

- The Competition starts on 12th November 2020 and closes on 14th November 2020 – which will be referred to as the competition period.
- Subject to the Terms and Conditions stated hereinafter, the winner is expected to be declared by the Promoter after the 15th of November.

2. Eligibility

- Subject to the provisions below, this competition is open to individuals who are resident in the United Arab Emirates.
- Provided that participation in this competition is by residents of the United Arab Emirates, the content of these Terms and Conditions are subject to regulations of the United Arab Emirates.
- Employees of the Promoter and their direct family members are not eligible to enter the competition.
- No purchase is required to participate in the Competition.
- Individuals who are registered as users on Facebook and Instagram must own an individual account through which only they can participate in this competition.

In these circumstances, the Participant/claimant for the prize shall not be entitled to winning.
